The Library Policy Advisory Committee roster is given in Appendix 1. During the academic year 2014-15 the committee met once in the spring.

The committee agenda for this past year was dedicated to information items. All libraries presented to the committee progress status reports and plans for future development. The libraries individually are developing or revising patron privacy policies to be discussed at a future committee meeting.

One item, in particular, drew interest from the committee for future study: whether the University can and should provide subsidies for open access article publishing. The committee recommends that the Faculty Senate create an ad hoc committee to assess what was learned in an earlier two-year pilot project and to make recommendations on this issue.

2. Eccles – Jean Shipman
Jean Shipman welcomed attendees to the Synapse space and described its purpose, mainly to provide a collaborative working space for innovators. She will distribute a link to a YouTube video that provides additional background. She discussed changes in faculty staffing – three faculty are retiring and two are being recruited. She will share the new alternative dissemination venue called e-channel that provides innovators with a way to share their output. She announced that the Elsevier Clinical Key resource had been licensed. She also reported on the results of the F&A study conducted recently for the Marriott and Eccles libraries; there was an increase in use of the libraries for research since the 2005 study.
